**Grant Report:** Jim believes an answer on the ITEP grant will be received in April. Believes the ITEP won’t be available for construction time in 2021. Dan requested we get signage up on the path regarding no motorized vehicles. Discussed placing a sign on the back of the stop sign posts.

**Annual Reports:** Reports were provided and no changes need at this time. Jen will post to the website.

**Give DeKalb County Membership:** Jen signed up the committee for this at the beginning of the month.

Jen asked who is responsible for the snow removal of the pathway between the school. Jim said it is up to the school if they want to do it.

Next pathway meeting is March 13, 2021 TBD.
