Approval of Minutes from May 8, 2021 Meeting: Wendy Schnorr motioned to approve the minutes, Mark Cinnamon seconded. All in favor voted aye. Motion carried.

Treasurer’s Report: Jim Johnson reported that we received over \$4600.00 from Give DeKalb County. Received notice that the application for the ITEP grant was received for \$440,000. This will be used to go south on Shabbona Road and link to Martensen subdivision and state park. Will need to find \$110,000 of local money for the matching portion. Jim proposed working with Dan to contact a local legislator to see if score can be improved by 1.5 and then 50% of matching portion would be forgiven. Mark Cinnamon said the Village is going to work toward the same goal for their grant application. Dan Nolan asked if the change in ownership of the Lovering property to the school district would change the process. It may eliminate having to purchase this portion of the property. Motion: Jen Morrison motioned to approve the treasurer’s report. Mark Cinnamon seconded. All in favor voted aye. Motion carried.

Bills: Jim reported that the person who formulated the plan for the pathway to access the state park has retired. Jim and Dan are trying to get a meeting with Bruce, the owner of the golf course who now owns the Kaus property.

Grant Report: Was reported above.

Give DeKalb County-Wrap Up: Discussed sending thank you to all of the donors. Jen said she was sending to all she had emails for.

Dan contacted his rep about getting more banners made. He said he would do it for the same price as previously created.

Discussed what would need to be done for a press release. Will wait until more information is received.

Terry Hannon invited members to the next Forest Preserve meeting which will be in July.

Next pathway meeting is July 10, 2021 at the Forest Preserve.
